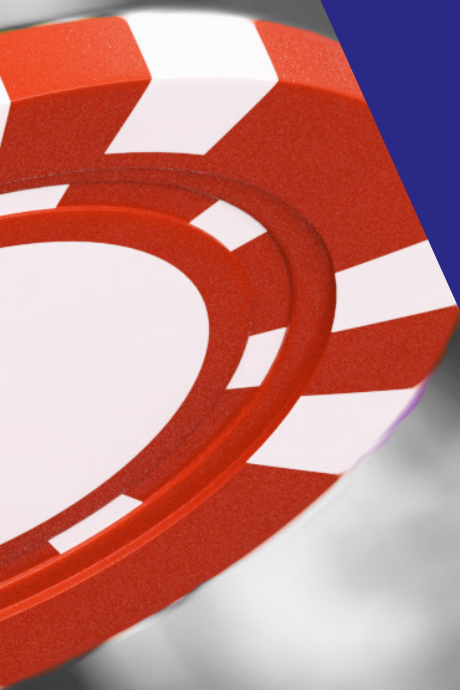

Licence Fees

The Jersey Gambling Commission offers Licences, Permits and Approvals in different categories:

Remote Gambling Operators Licence	£15,000
Application Fees	£5,000
<small>(A further fee of £5,000 may be requested if the cost of the application fee exceeds the first tranche)</small>	
Alterations Costs	£250
Platform Providers Permit	£10,000
Application Fees	£5,000
<small>(A further fee of £5,000 may be requested if the cost of the application fee exceeds the first tranche)</small>	
Mirroring & Load Balancing Services Licence	£5,000
Application Fees	£500
<small>(A further fee of £500 may be requested if the cost of the application fee exceeds the first tranche).</small>	
Alterations Costs	£250
Late Payment Fee	10% of the licence fee, pro-rata

The Commission will monitor the level of fees and whether they do, in fact, meet the costs of regulatory oversight and will make a determination after one year.

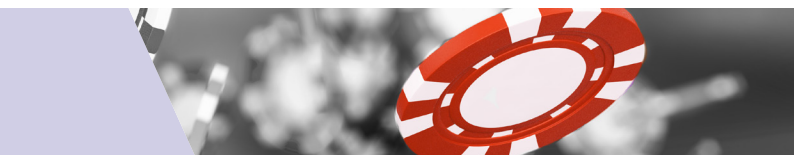
